Melbourne Career Expo Event Guide Advertising Terms & Conditions

- 1. This agreement is made between Careers Exhibitions Pty Ltd ABN: 27 612 019 244 ("The Organisers") and the organisation agreeing to advertise ("Advertiser"). The agreement is relevant from the period beginning the 30 July 2025 to the 20 July 2026. It is in respect to the 2023 Melbourne Career Expo which is held on the 26-28 July 2024, at the Melbourne Convention and Exhibition South Wharf, Melbourne. The Advertiser agrees to the following terms and conditions.
- 2. The person who signs this Advertising Agreement is authorised to sign on behalf of the advertising organisation. Should the contact person change prior to the event date, the advertiser must notify the organiser. The advertising organisation will still be responsible for the production of the advertisement and is liable for the expense of the advertisement. Change of booking contact is not reason to void this agreement.
- Upon receiving a signed Advertising Agreement, your organisation's advertisement is considered as confirmed for the
 event guide. An invoice will be raised for the chosen advertisement and is due to be paid in full no later than Friday 31st
 May 2026. All prices guoted are GST inclusive.
- 4. Any cancellation received after Friday 2 May 2026 will be subject to a 100% cancellation fee which will be due for payment in full no later than Friday 31st May 2026.
- 5. The Melbourne Career Expo Event guide will be a Full Colour A4 publication which will include the Event Map, Exhibitor List and full expo schedule. This guide will be a minimum of 8 pages with increased pagination subject to advertising take up.
- 6. Any advertising booking of 1/4 page or above will also receive the equivalent space complimentary to use for advertising, advertorial, or pictorial inclusion.
- 7. All advertising bookings must be received no later than Friday 29 May 2026.
- 8. All advertisements must be received in print ready PDF format, with no bleed or cut lines, no later than Friday 5 June 2026.
- 9. If you require artwork to be produced for your organisation, we can give you our design company details to assist with ad production. Please note that any ad production is at the advertiser's expense.
- 10. Once advertisement has been received by the Organiser the advertisement is deemed to be approved for print by the Organisation. Changes will not be permitted after Friday 5 June 2026.
- 11. All advertising organisations will also receive their company logo displayed on the entrance plasma, stage screen between activities and on www.careerexpo.com.au links page. The advertising organisation must submit a high quality JPEG logo no later than Friday 5 June 2026. If logo is not received by this date, it may not be included in this upgrade and no compensation will be given.
- 12. Event Guide in digital format (Flip Book) will be included on our website from July 2026 until start of June 2027.
- 13. Advertisements must not include any inappropriate language or images. The Organisers reserve the right to reject any submissions deemed inappropriate for the target audience.
- 14. Organisers reserve the right to prohibit in whole or in part and reject any exhibitor advertisement/editorial content in the case of failure to comply with the rules and regulations.
